Sub: Third Corrigendum to the Postal Ballot Notice to the Unitholders of Oriental InfraTrust

Please be informed that Oriental InfraTrust (the "**Trust**") through its Investment Manager, OIT Infrastructure Management Limited, has issued a postal ballot notice dated October 19, 2024 and explanatory statements ("**Postal Ballot Notice**"), along with corrigenda dated (i) November 9, 2024 ("**Corrigendum I**"); and (ii) December 4, 2024 ("**Corrigendum II**") to the Postal Ballot Notice for the matters proposed to be considered and approved by the Unitholders of the Trust ("**Unitholders**").

The Postal Ballot Notice has been dispatched to the Unitholders on October 19, 2024. Subsequently, the Corrigendum I and Corrigendum II have been dispatched to the Unitholders on November 9, 2024 and December 4, 2024, respectively in due compliance with the provisions of the SEBI (Infrastructure Investment Trust) Regulations, 2014 read with paragraph 14.3.1(e) and other provisions of the Master Circular on Infrastructure Investments Trusts issued by SEBI, bearing number SEBI/HO/DDHS-PoD-2/P/CIR/2024/44 dated May 15, 2024, as amended.

We are hereby submitting this corrigendum dated December 16, 2024 to the Postal Ballot Notice ("Corrigendum III", and collectively with Corrigendum I and Corrigendum II as "Corrigenda") informing the Unitholders about the changes in the Postal Ballot Notice with respect to the agenda and resolutions for consideration and approval of the Unitholders of the Trust ("Unitholders") and last date of exercising the votes and submission of postal ballot form by the Unitholders.

In terms of the Postal Ballot Notice read with the Corrigendum II, the Unitholders were requested to record their decision in the Postal Ballot Form and submit the same duly completed and signed with the Scrutinizer not later than 17:30 hours IST on or before December 16, 2024.

However, on account of logistical reasons, set forth below are the modifications to the Postal Ballot Notice:

- a. the agenda and the resolutions for considerations have been modified and the Unitholders will be required to submit their decisions in relation to the Items Nos. 1 and 3 (as mentioned in the Postal Ballot Notice) only. Item No. 2 (as mentioned in the Postal Ballot Notice) is omitted from the Postal Ballot Notice. A revised Postal Ballot Form has been annexed to this notice.
- b. the last date of exercising the votes and submission of postal ballot form by the Unitholders has been changed, and duly completed and signed Postal Ballot Form should now be submitted with the Scrutinizer not later than 17:30 hours IST on or before December 20, 2024.





Accordingly, this Corrigendum III is being issued in continuation to the Postal Ballot Notice, and Corrigenda shall be read in conjunction with the Postal Ballot Notice. This Corrigendum III shall form an integral part of the Postal Ballot Notice which has already been circulated to the shareholders of the Company. Except as detailed in Corrigenda, all other terms and contents of the Postal Ballot Notice shall remain unchanged.
